

**INVESTMENT OBJECTIVE**

The Ampersand BCI Income Fund aims to secure a higher return than that of a traditional money market or pure income fund and focus on protection against capital loss for investors.

**INVESTMENT POLICY**

In order to achieve the objective, the portfolio will invest in a combination of income generating assets. The portfolio's net equity exposure will be a maximum of 10% of the portfolio's asset value. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. Investments to be acquired for the portfolio may include equity securities, property securities, property related securities, notes, interest bearing securities, non-equity securities, money market instruments, preference shares and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments.

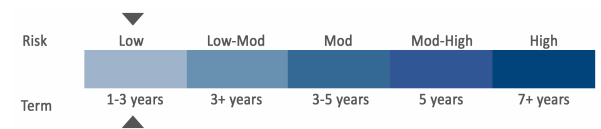

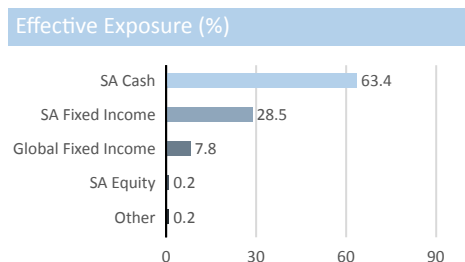
**Low Risk**
